Income tax department Communication

Income Tax Department (Exemptions Range), Chhatrapati Sambhajanagar along with Chhatrapati Sambhajanagar branch of ICAI(WIRC) jointly organised an outreach cum interaction programme for Trusts. The objective of the programme was to create awareness among the trustees as well as tax professionals regarding the provisions of Income Tax Act with respect to Trusts.

During the programme, Advocate Chandrakant Varudikar emphasised on the importance of Income Tax related compliances under the Bombay Public Trust Act including the filing of Income Tax Returns. Joint Commissioner of Income Tax Exemptions Aurangabad Shri Eknath Abhang, Deputy Commissioner of Income Tax Exemptions Aurangabad Shri Mukul Kulkarni and Income Tax Officer Exemptions Aurangabad Shri Gopal Gaikwad urged the trusts to file Income Tax Returns and Audit Reports within the due date failing which the exemption to the trust may be denied. Further they informed the trustees and tax professionals that all the trusts registered u/s 12A/12AB/80G with effect from 01.04.2021 will have to renew their registration by making an online application before 30th September 2025 as the validity of registration of these trusts is till 31st March 2026.

If the trusts do not renew their registration then they will lose their exemption status after 31st March 2026. Further the officers also clarified that the increase in registration tenure for small trusts (below 5 crore receipts) from 5 years

to 10 years is not automatic. All small trusts (having receipts below 5 crore) will also have to apply for renewal of registration before 30th September 2025. If their registration is renewed then their registration will remain valid for 10 years. In his address, the Chief Guest of the programme, Commissioner of Income Tax Exemptions Pune Dr Shri Nitin Waghmode explained the process of registration and renewal and also explained the documents required for the same.

He explained that along with Income Tax Act, the trust is also required to follow the other applicable laws such as Bombay Public Trust Act etc and violation of other laws can also result in registration being rejected. He explained that the trusts will get maximum 3 opportunities to furnish the required documents before a decision regarding their registration is taken. He also urged the trustees and the trust management to co-operate with the tax professionals and provide them with the necessary information and documents within time. The officers also took questions from the audience and addresses their queries
